Capitol Capital: The Consequences of Economic Inequality Within the U.S. Congress (under review)

Summary: This book manuscript explores the impact of economic inequality within the U.S. Congress over the past 40 years. It examines how disparities in wealth among legislators affect their electoral strategies, legislative effectiveness, and representation. The analysis reveals significant differences between wealthier and less-wealthy members of Congress, demonstrating how the former group benefits from structural advantages that enhance their political power. This research contributes to the understanding of how economic inequality among elites shapes political inequality in American politics.
